Plainville School Committee Meeting December 13, 2016 Regular Session

CALL TO ORDER

The meeting was called to order by Chairperson Amy Abrams at 4:03 p.m. in the Wood School Music Room. Also present were Maggie Clarke, Javed Ikbal, Charlene McEntee and Superintendent Raiche. The meeting was audio and video recorded. Absent: Linn Caprarella

NEW BUSINESS (4:00 p.m.)

• ESSA, Every Student Succeeds Act, Glenn Koocher, MASC

Glenn Koocher, Executive Director of the Massachusetts Association of School Committees, presented information on the *Every Student Succeeds Act (ESSA)*, which is a federal program comprised of nine õTitlesö that provide funding to states and school districts. In return for funding, states and school districts must comply with requirements of the law. The õTitlesö include:

- Title I, Improving the academic achievement of the disadvantaged,
- Title II Preparing, training & recruiting high-quality teachers, principals, or other school leaders
- Title II, Language instruction for English learners & immigrant students
- Title IV, 21st century schools
- Title V, Flexibility & accountability, Innovations
- Title VI, Indian, native Hawaiian, & Alaska Native education
- Title VII, Impact Aid
- Title VIII, General provisions (Local District governance) and
- Title IX. Education for the homeless, victims of abuse and other laws.

Mr. Koocher stated, õMassachusetts has already done what the law states.ö For most districts Title I is the major component. He outlined various components such as the *General Goals* for the law (continue to require attention to students at greatest social and academic risk, transfer authority to local decision makers, flexibility to local decision makers on tests and accountability and limits on authority of U.S. Secretary of Education), *accountability* (set ambitious goals for achievement, graduation rates and success for English language learners) and *accountability measures* (track academic achievement toward goals, student growth indicators, graduation rates, English proficiency and measure of school quality).

Linn Caprarella arrived at 4:42 p.m.

In addition, he spoke about 21st century schools, Title IV, which speaks to the areas of gifted and talented programs, advanced placement, community schools/extended day,

charter schools and arts. Mr. Koocher stated that the advocacy of the Plainville School Committee to sponsor this presentation is commendable. Mrs. Abrams thanked Mr. Koocher for his thorough presentation on ESSA.

NASA Project ó Caitlin Nunez, Grade 4 Teacher:

At 5:55 p.m. the Committee went to the grade 4 classroom of Caitlin Nunez. The following students: Catherine Antinoro, Jack Assini, Skyler Bouffard, Neela Caruso, Victor Dorcena, Joey Flood, Mackenna Jones, Haleigh Ricci, and Ella Sheehan showcased their work relating to the NASA project. Mrs. Nunez explained the process for being selected as a pilot classroom for the NASA project. WGBH sponsored the project, she applied and was one of 50 teachers nationwide selected to participate. NASA and Oregon State University funded the program.

Mrs. Nunez and the students used a <u>Clear Touch Board</u> to demonstrate their work on *The Role of Water on Earth* using three componentsô interactive, lesson plan and additional resources. As a pilot teacher, Mrs. Nunez is reporting to WGBH on her thoughts and the studentsøreaction to the project. It was clear from the enthusiasm of the students that they greatly enjoyed using the program and learning about the role of water. It was noted that the content of the program aligns with the science standards for grades 4 and 5 (ESS2-2 and ESS2-1).

Mrs. Abrams thanked Mrs. Nunez, the students and their parents for attending the school committee meeting and showcasing their work.
